### Validity period for consent to processing personal data and method of withdrawal (unless otherwise specified by federal law):

The subject's personal data is subject to storage for any periods outlined by Russian law. Personal data is destroyed in the following circumstances: upon fulfilment of the reasons behind processing the personal data; upon liquidation or reorganization of the operator, or upon written request made by the subject of the personal data. In the latter instance, the operator will cease processing the personal data within 3 (three) working days, upon which the subject will be sent written notification within 10 (ten) working days.
